Approval of October 2019 Meeting Report

A motion was made and seconded to approve the October Meeting Report.

Guest Speaker: Senator Brian Dahle (R – Bieber)

Chris Shimoda gave a brief introduction, followed by a short speech from Senator Dahle about his background and the political landscape in Sacramento.

Senator Dahle answered questions from committee members and AMC attendees – regarding political engagement, Split Roll, the 2020 election, campaigning and vulnerable seats in the California State Legislature, the insurance industry as it relates to wildfires and forestry issues, small businesses and privacy.

2020 Primary Review

CTA staff discussed the upcoming March primary and the open seats/primary challenges: AD 13 (Eggman), SD 13 (Hill), SD 15 (Beal), AD 57 (Calderon), SD 7 (Glazer), AD 72 (Diep).

Legislator of the Year

The CTA staff recommendation for 2020 Legislator of the year was Assemblymember Adam Gray (D – Merced) due to his vote on AB 5, as the only Democrat to vote against the bill.

A motion was made and seconded to approve Assemblymember Gray as 2020 Legislator of the year.

Grassroots Update: Draft Kingpin Guidance Document

CTA staff summarized the draft guidance document and its purpose, which is to provide unit leaders with guidelines for how best to support CTA's advocacy initiatives. CTA will continue to fine tune the advocacy guidance document, with input from the committee and CTA's board.

Trucking Day & Call on Washington

CTA staff provided an overview of the two main upcoming advocacy events: Trucking Day and Call on Washington. CTA staff discussed the structure of Trucking Day, which will include a CARGO PAC reception the night before. The structure for Call on Washington was also discussed. Staff outlined the preliminary agenda and encouraged members to attend.
