Approval of June 2020 Meeting Report

A motion was made and seconded to approve the June Meeting Report.

2020 Election Review

During the election day meeting, CTA staff discussed the important seats to watch as the results begin to come in, starting with the most vulnerable seat for the Republicans – SD 37 (Moorlach). Staff broke down the voter registrations and possible outcomes for other key seats: SD 29 (Newman & Ling Ling Chang), SD 21 (Wilk & Mueller), SD 21 (Medina & Ochoa Bogh), SD 15 (Ravel & Cortese), AD 72 (Diedre Nguyen & Janet Nguyen), AD 68 (Choi & Melissa Fox), AD 36 (Lackey & Steve Fox), AD 35 (Cunningham & Dawn Addis), AD 55 (Chen & Andrew Rodriguez), AD 59 (Jones-Sawyer & Efren Martinez).

Following the review of individual seats, staff discussed best/worst/likely outcomes of the post-election make-up of the Senate and Assembly. Lastly, staff covered polling and possible outcomes for two ballot measures of interest to the industry: Prop 15 (Split Roll) and Prop 22 (App-Based Driver Exemption from AB 5).

Tentative 2021 Trucking Day & Call on Washington

Staff informed the Committee that it is still unknown as to whether COW 2021 will occur. 2021 Trucking Day has been tentatively scheduled for Fall of 2021 and CTA is planning for a virtual event since access to the Capitol for lobby days may be restricted throughout 2021.

Kingpin 2021 Engagement

With continuing uncertainty about in-person events, CTA will be proceeding with "virtual shed events" for 2021. CTA revisited the Kingpin 2.0 plan with virtual options instead of in-person events. Government Affairs staff will work with the Units to plan one or two virtual events for local lawmakers throughout the year.
